B. IN ORDER TO GET THE PROGRAM MOVING AT THE EARLIEST POSSIBLE BATE, I AGREED TO THE PREPARATION OF A WORK STATEMENT PREPARED BY A JOINT TEAM OF MEMBERS FROM PROGRAMS A AND B.

I RESOMMEND DIRECTOR, PROGRAM A APPOINT A CHAIRMAN FOR THIS C. I AGREE THAT EASTMAN-KODAK, ITEK, FAIRCHILD, PERKIN-ELMER AND HYCON CONSTITUTE THE AVAILABLE INDUSTRY CAPABILITY AND SHOULD BE ASKED TO SUBMIT PROPOSALS. I AGREED TO A JOINT PROPOSAL EVALUATION BOARD. PROPOSE COLONEL CHARLES MURPHY AS CHAIRMAN OF THIS BOARD.

2. I DID NOT AGREE WITH DIRECTOR, PROGRAM A ON THE PLAN FOR OVER-ALL MANAGEMENT OF THIS PROGRAM. THE VARIOUS APPROACHES
TO QUESTIONS OF OVER-ALL MANAGEMENT, CONTRACTING AND SECURITY WERE DISCUSSED INFORMALLY, BUT NO CONCLUSIONS WERE REACHED.
MY APOLOGIES IF I DID NOT MAKE MYSELF CLEAR ON THIS POINT.
THE ENTIRE PROBLEM OF ASSIGNMENT OF FUNCTIONS AND RESPONSIBILITIES WITHIN THE NRP IS AT PRESENT A SUBJECT BEING DEHATED AT HIGHER LEVELS AND ANY AGREEMENT ON PROGRAM MANAGEMENT MUST NECESSARILY AWAIT A MAJOR POLICY DECISION. I RECOMMEND THAT WE PROCEED WITH THE WORK STATEMENT AND EVALUATION ON A JOINT BASIS UNTIL OVER-ALL REP MANAGEMENT RESPONSIBILITIES ARE DEFINED AT HIGHER LEVELS.
