Dr. McLucas is delegated the authority to act for me on all Air Force matters -- including personnel, materiel, and fiscal resources -associated with the National Reconnaissance Office and/or within the purview of the National Reconnaissance Program, including the MOL reconnaissance payloads.



#### MEMORANDUM FOR DR. SEAMANS

I have forwarded to Mr. Packard a memorandum for his signature (copy attached) appointing Dr. McLucas Director of the NRO as additional duty effective March 17, 1969.

The attached memorandum for your signature delegates to Dr. McLucas authority over SAFSS and SAFSP. It is a paraphrase of the one Dr. Brown wrote in 1965 at the time of my appointment as Director of the NRO (a copy is attached). Strictly, since the Under Secretary already has delegated to him virtually all authority vested in the Secretary, the memorandum confers no new authority in Dr. McLucas. However, it does make clear to the other Assistant Secretaries and the Chief of Staff that they are


