THIS MESSAGE IS INTENDED TO PROVIDE ASSISTANCE AND AUTHORITY TO CONDUCT A COVERT CONTRACT BETWEEN [REDACTED] FOR THE STUDY OF POTENTIAL NASA USAGE OF DORIAN ATS AND MISSION DEVELOPMENT SIMULATOR IN CONNECTION WITH THE APOLLO APPLICATION PROGRAM.

PART I - FUNDING

A COPY OF THE WORK STATEMENT COVERING THE EFFORT THAT GE IS TO ACCOMPLISH FOR NASA WAS SENT TO YOU UNDER SEPARATE COVER 14 NOV 69. AN OBLIGATION AUTHORITY FOR \$225K WILL BE ISSUED TO FUND THIS EFFORT. REQUEST YOU PREPARE AND NEGOTIATE A CONTRACT WITH GE BASED ON THE WORK STATEMENT AND FUNDING INFORMATION

PROVIDED. THE CONTRACT SHOULD STIPULATE THAT ALL COST MUST REMAIN WITHIN THE SPECIFIED LIMITES OF GOVERNMENT OBLIGATION AS INDICATED.

PART II - MANAGEMENT

IT IS UNDERSTOOD THAT WHILE YOU ARE THE CONTRACTING AUTHORITY, NASA WILL PROVIDE TECHNICAL DIRECTION TO THE CONTRACTOR AND IS AUTHORIZED DIRECT CONTACT FOR THIS PURPOSE. NASA VISITOR CONTROL WILL BE ESTABLISHED THROUGH WASHINGTON SAFSL OFFICE. IT IS ANTICIPATED THAT A MID-TERM AND FINAL REVIEW WILL BE CONDUCTED THE CONTRACTOR'S PLANT.

PART III - SECURITY

THE SECURITY OBJECTIVE IS TO CONDUCT THE STUDY WITHIN THE BYEMAN SYSTEM WITH THE CAPABILITY TO PRODUCE TOTALLY NON-BYEMAN FINAL PRODUCT IF REQUIRED. TO ACCOMPLISH THIS, THE FOLLOWING POINTS ARE RECOMMENDED FOR THE SECURITY ANNEX:

- A. THE CONTRACT BE CONDUCTED AS A NUMBERED BYEMAN STUDY, LIMITED

TO THOSE SYSTEMS SPECIFIED IN THE WORK STATEMENT. (THE NUMBERED STUDY WILL NOT INCLUDE MAIN OPTICS DATA.)

B. ALL BYEMAN DOCUMENTS WILL BE CONTROLLED UNDER THE STUDY NUMBER. NO REFERENCE TO DORIAN WILL BE MADE. DOCUMENTATION FOR THE FINAL REPORT AND ALL SUPPORTING DOCUMENTS WILL BE NON-BYEMAN, PREPARED

UNDER BYEMAN CONTROL IN SUCH A FASHION THAT IT MAY BE READILY RELEASED IN COLLATERAL CHANNELS (SECRET/CONFIDENTIAL/UNCLASSIFIED) AS APPROPRIATE.

C. THE FINAL REPORT WILL NOT BE SURFACED UNTIL REVIEWED BY SAFSP AND/OR SAFSL TO INSURE THAT NO BYEMAN INFORMATION IS CONTAINED OR IMPLIED IN THE REPORT. IN ADDITION, THE REPORT WILL BE RELEASED ONLY UPON THE REQUEST OF NASA IN THE EVENT THAT THEY ELECT TO UTILIZE THE SYSTEM/TECHNOLOGY. THIS DATA WILL NOT BE USED BY THE CONTRACTOR FOR MARKETING PURPOSES UNLESS SPECIFICALLY AUTHORIZED BY SAFSP AND SAFSL.

D. ACCESS APPROVALS FOR THE STUDY WILL BE THE RESPONSIBILITY OF SAFSP FOR THE CONTRACTORS AND SAMSO, AND BY SAFSL FOR NASA AND USAF. VISIT CERTIFICATIONS WILL BE BY ACCESS APPROVING AUTHORITY.

E. ACCESS TO GOVERNMENT PERSONNEL CURRENTLY AUTHORIZED DORIAN ACCESS WILL NOT REQUIRE A FORMAL SIGN UP. THEY MUST BE BRIEFED ON THE SCOPE OF THE STUDY (INTRODUCTION TO WORK STATEMENT).

F. CONTRACTOR PERSONNEL SOLELY REQUIRING ACCESS TO DATA DEVELOPED UNDER THE DORIAN CODE NAME FOR THE PURPOSE OF THE STUDY WILL BE DEBRIEFED DORIAN AND REINDOCTRINATED UNDER BYEMAN STUDY-----, WHICH WILL GRANT ACCESS TO DORIAN INFORMATION WITHIN SCOPE OF THE
